3. **Bid Price**

- a) The contract shall be for the full quantity as described above.
- b) Corrections, if any, shall be made by crossing out, initialing, dating and re writing.
- c) All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
- d) The rates quoted by the bidder shall be fixed for the duration of contract.
- e) The Prices shall be quoted in Indian Rupees on ex-godown district project headquarter.
- f) The fertilizer should be as per specification specified in Fertilizer Control Order 1985.
- g) If fertilizer found below standard, the fertilizer will be returned to the supplier on his own cost.
- h) The bidder should quote only the rate of above fertilizer mentioned in quotation format.
- j) The prices quoted for each schedule shall correspond at least to 100 % quantity specified for corresponding schedule for which bidder applied for.
- k) Bidder can quote for one or more schedules, for the complete requirement of corresponding schedule for which applied for.

4. Bidder can quote for as many schedules as they wish to **but** can only submit **one quotation per schedule**. This is to clarify that If the bidder has more than one firm in different names with same ownership then he shall not apply for the same schedule with names of different firms with same ownership. Bidder shall not contact other Bidders in matters relating to this Quotation.

5. **Validity of Quotation**

Quotation shall remain valid for above mentioned period not less than 60 days after the deadline date specified for submission.

6. **Evaluation of Quotations**

- (i) The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which
 - (a) are properly signed ; and
 - (b) conform to the terms and conditions, and specifications.
 - (c) are in the quotation format provided with this invitation letter.
- (ii) The Quotations would be evaluated item wise.

7. **Award of contract**

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price .

7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order (sample form attached).

8. Payment shall be made against delivery of the goods.

9. Normal commercial warranty/ guarantee shall be applicable to the supplied goods.
